THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Denmark notified its national allocation plan table to the Commission by letter dated 16 January 2008, and the Commission, by its Decision of 26 February 2008², has instructed the Central Administrator of the Community Independent Transaction Log to enter Denmark's National Allocation Plan table into the Community Independent Transaction Log,
- (2) Denmark notified corrections to its national allocation plan table by letters dated 24 February 2009 ,
- (3) the Commission found that the corrections notified for installations DK-390, DK-149, DK-396 and DK-430 are inadmissible because they are not in accordance with the methodologies set out in Denmark's national allocation plan, with the rest of the corrections being in accordance with these,
- (4) On 26 February, Denmark notified an amendment to the correction for installation DK-340 which is in accordance with the methodologies set out in Denmark's national allocation plan,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to Denmark's National Allocation Plan table into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.
