THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) The Slovak Republic notified by letter dated 26 May 2008 its partial allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its partial national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 20 June 2008², has instructed the Central Administrator of the Community Independent Transaction Log to enter the partial National Allocation Plan table of the Slovak Republic into the Community Independent Transaction Log,
- (2) The Slovak Republic notified additional allocations to be introduced in its national allocation plan table by letters dated 9 October 2008 and 25 November 2008, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of the Slovak Republic, as revised, without objections from the Commission, on the basis of Commission Decisions of 29 November 2006 and of 7 December 2007, and respects the total quantity permitted by these Decisions,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of the Slovak Republic into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.


