THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>1</sup>, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) The Slovak Republic notified by letter dated 26 May 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 20 June 2008<sup>2</sup>, amended by its decisions of 28 November 2008<sup>3</sup> and of 27 February 2009<sup>4</sup> has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of the Slovak Republic into the Community Independent Transaction Log,
- (2) By letter dated 18 May 2011 the Slovak Republic notified to the Commission corrections to its National Allocation Plan table for the period 2008-2012 in line with Article 44 (2) of Commission Regulation (EC) No 2216/2004,

HAS DECIDED AS FOLLOWS

### *Article 1*

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Slovakia into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.
