THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Romania notified by letter dated 27 November 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 17 December 2008² as amended by its Decision of 31 July 2009³, 29 September 2009 and 29 March 2010⁴, has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Romania into the Community Independent Transaction Log,
- (2) Romania notified additional corrections to be introduced in its national allocation plan table due to the application of Romania's new entrants' provisions by letter dated 6 April 2010, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Romania, as revised, without objections from the Commission, on the basis of Commission Decision of 26 October 2007⁵, and respects the total quantity permitted by this Decision,
- (3) A typographical error was introduced in the Commission's decision on instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Romania into the Community Independent Transaction Log dated 29 March 2010⁶, that needs to be corrected.

HAS ADOPTED THIS DECISION

Article 1
