THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Romania notified by letter dated 27 November 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 17 December 2008², has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Romania into the Community Independent Transaction Log,
- (2) Romania notified additional allocations to be introduced in its national allocation plan table by letter dated 9 October 2008, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Romania, as revised, without objections from the Commission, on the basis of Commission Decision of 26 October 2007³, and respects the total quantity permitted by this Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Romania into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.

Article 2

The corrections to the National Allocation Plan table of Romania are represented in the Annex.
