THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the periods ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 37 (2) second sentence thereof,

Whereas:

- (1) Romania notified by letter dated 27 November 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 17 December 2008² as amended by its Decision of 31 July 2009³, 29 September 2009, 29 March 2010⁴, 04 July 2010⁵, and of 06 March 2012⁶, has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Romania into the Community Independent Transaction Log,
- (2) By letter dated 28 December 2012 Romania notified to the Commission corrections to its national allocation plan table. The corrections arise from the non-issuance of ERUs from the set-aside established under Commission Decision 2006/780/EC⁷ on avoiding double counting as a result of non-completion of JI projects and the subsequent increase by Romania of the number of allowances to be auctioned pursuant to the first sentence of Article 5(2) of that Decision and an increase in the free allocation for installations RO-28, RO-76, RO-83, RO-134, RO-204 pursuant to the second sentence of Article 5(2),
