COMMISSION DECISION

instructing the Central Administrator of the European Union Transaction Log to enter corrections to the National Allocation Plan table of the Czech Republic into the European Union Transaction Log

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the periods ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 37 (2) second sentence thereof,

Whereas:

- (1) The Czech Republic notified by e-mail dated 2 August 2010 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 21 February 2008² as amended by Commission Decision of 17 April 2009³, 25 October 2010⁴, of 12 December 2011⁵ and of 20 February 2012⁶, has instructed the Central Administrator of the European Union Transaction Log to enter the National Allocation Plan table of the Czech Republic into the European union Transaction Log,
- (2) By letter dated 20 December 2012 the Czech Republic notified to the Commission corrections to its national allocation plan table. The change represents an improvement in data related to the decrease of the JI set aside reserve in accordance with article 5(2) of Commission Decision 2006/780/EC⁷ on avoiding double counting as a result of non-completion of JI projects, and equivalent increase of the reserve for auctioning,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the European Union Transaction Log to enter the corrections to the National Allocation Plan table of Czech Republic into the
