THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the periods ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 37 (2) second sentence thereof,

Whereas:

- (1) Bulgaria notified by letters dated 8 January 2010 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004,
- (2) Bulgaria notified amendments to its allocation decision and national allocation plan table by letter dated 14 April 2010, and the Commission found by letter dated 16 April 2010 that as amended the notified national allocation plan table corresponded to the allocation decision and is based upon the national allocation plan notified by Bulgaria, as revised, without objections from the Commission on the basis of Commission Decision of 26 October 2000²,
- (3) The Commission, by its Decision of 26 April 2010³, as amended by Commission Decisions of 23 April 2012⁴ has instructed the Central Administrator of the Community Independent Transaction Log to enter the national allocation plan table of Bulgaria into the Community Independent Transaction Log,
- (4) Bulgaria notified to the Commission by letter dated 14 November 2012 corrections to its national allocation plan table which represent a transfer of allowances from the set-aside double counting reserve for the Joint Implementation Mechanism to the New Entrant Reserve and the reserve for auctioning in accordance with the revised Bulgaria's national allocation plan following the exchange of correspondence between the Commission and the Bulgarian Minister of Environment and Waters on 14 and 16

HAS DECIDED AS FOLLOWS:

Article 1
