# EUROCONTROL's Support Facilities – ETSSF



EUROCONTROL, an intergovernmental organisation (30 EEA States + 11 States, ECAC wide)

### • ETS Support Facility (ETSSF)

- Support to States implementing the EU ETS, to Switzerland (CH ETS) and to UK (UK ETS)
- Support to European Commission (DG CLIMA) in defining the EU ETS List
- Support to aeroplane operators in complying to ETS (can include third parties authorised by operators, e.g. verifiers, leasing companies)

### ETS OBI Portal

• Support to States to understand the EU ETS List (situation snapshot at time of list production)

## **EUROCONTROL's Support Facilities – EMIS**



#### • Environment Management Information Service (EMIS)

- Shall replace the ETSSF (started 2010)
- Collection of modules
- ETS Support Facility (ESF, successor of the ETSSF for States)
  - Support to States implementing the EU ETS, to Switzerland (CH ETS) and to UK (UK ETS)
  - Support to European Commission (DG CLIMA) in defining the EU ETS List
- CORSIA Support Facility (CSF, complements ETSSF for EU States)
  - Support to States implementing the EU ETS
  - Support to any other State (today Switzerland and UK)
- CORSIA Reporting Tool (CRT)
  - Support to States to generate the aggregated report to be uploaded in ICAO's CORSIA Central Register (CCR)
- Report Checker (RC)
  - Support to aircraft operators to check to a large extent their CORSIA related report to minimise issues when used by a State in the CRT

# 2021 Enhancements of the ETSSF/EMIS



### • January

- Completed the load of the 2020 data, emissions computed with the Small Emitters Tool (SET) 2020
- Delivered to DG CLIMA the EU List reflecting Brexit
- February, deployed the EMIS CSF
- March, deployed the prototype of the EMIS RC for feasibility assessment
- June, deployed the 2021 version of the EMIS CRT
- Upcoming
  - Deployment of the EMIS ESF (shadow operations with the ETSSF for States)
  - Deployment via the EMIS CSF of worldwide intention data (sourced from FlightGlobal's Innovata)
  - Publication of the SET 2021
  - Deployment of data reflecting the changes in scope of the EU ETS following Brexit

### Other related activities in 2021



- Contributed to the work of the Compliance Forum Aviation Task Force
- Romania became the 26<sup>th</sup> user of the ETSSF (24 EEA States + CH + UK)
- Formalised the States Users Task Force (SUTF) of the ETSSF Steering Group
  - Met twice since May 2021
  - 3 meeting of the SUTF working groups
- Signed new Cooperation Agreement with DG CLIMA (August 2021→March 2024)
- Reviewed the Fit for 55 proposal on ETS and provided feedback to DG CLIMA

- Signed data exchange agreement with Singapore Civil Aviation Authority (CAA)
- Collected actual fuel burn data from aircraft operators on a voluntary basis
  - Assessed impact of COVID: April 2020→March 2021 vs. previous data presents 3%~8% reduction
  - Completing the production of the SET 2021
- Evaluated worldwide ADS-B derived data from a commercial data supplier: agreement in negotiation final phase
- ETSSF Steering Group 22<sup>nd</sup> meeting on 2 December 2021
  - Proposed extension of the ETS Agreement 1 January 2022 → 31 December 2022

### 2022 Main Milestones



- January: delivery of the EU List for 2022 to DG CLIMA
- Q1
  - Completion of the 2022 data integration
  - Deployment of the aerodrome pair view in the EMIS ESF
  - Deployment of the 2022 version of the EMIS RC for use by aircraft operators
  - Integration of the Singapore CAA data (available via the EMIS CSF)
  - Integration of the worldwide ADS-B derived data (available via the EMIS CSF)
- May: deployment of the 2022 version of the EMIS CRT
- Q3
  - Decommissioning the ETSSF for Competent Authorities, replaced by the EMIS ESF
  - Collection of actual fuel burn data from voluntary aircraft operators
  - Development of the SET 2022
  - Migration of the reports management capability of the ETSSF for aircraft operators into EMIS
- December: EMIS Agreement signature
