




One example: MSR design \rightarrow price \rightarrow abatement



- Leaving the intake rate at 24% will increase the EUA price with 25% compared to the current set-up where the intake rate returns to 12% in 2024
- Average price 2021-2030:
 - €47/t (24+12)
 - €61/t (24)
 - €29/t (24+0)




One example: MSR design \rightarrow price \rightarrow abatement



- 34% more abatement realised 2021-2030 if the 24% intake rate prolonged
- But what abatement is triggered?



One question: Price trigger points for abatement?



- Different dynamics in power and industry sector abatement profiles
- More direct link price → abatement (fuel switching) in power sector
- Slower response in release of industy sector abatement potential (lead time, support needs, technology maturity)


