# Public consultation referred as "consultation" in the text

### 1. OBJECTIVE

The objective of this consultation is to receive the views of stakeholders or people concerned by the topic of the consultation and potentially to publish them on the Internet, under the responsibility of the Head of the Unit "Road transport" Directorate-General Climate Action (CLIMA), acting as the processor of personal data collected for the participation in the consultation.
