Instructing the Central Administrator of the European Union Transaction Log¹ to enter corrections to the National Allocation Plan Table of Poland into the European union Transaction Log

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010² establishing a Union Registry for the period ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council³, and in particular Article 37(2) thereof,

Whereas:

- (1) Poland notified by letters dated 17 July 2008 and 12 March 2009 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 27 March 2009⁴ has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Poland into the Community Independent Transaction Log,
- (2) Poland notified to the Commission by letter dated 17 February 2012 corrections to be introduced in its National Allocation Plan table to delete the installation PRODUKCJA MATERIAŁÓW CERAMICZNYCH KŁOŚNIK with identifier No 877 since it does not have a permit for the period 2008-2012 and can not obtain such permit till the end of 2012,
