## COMMISSION DECISION

**instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Ireland into the Community Independent Transaction Log**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>1</sup>, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Ireland notified by letter dated 13 March 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 17 March 2008<sup>2</sup>, amended by its decision of 5 June 2009<sup>3</sup> has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Ireland into the Community Independent Transaction Log,
- (2) Ireland notified additional allocations to be introduced in its national allocation plan table by letter dated XX December 2009, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Ireland, as revised, without objections from the Commission, on the basis of Commission Decision of 29 November 2006<sup>4</sup>, and respects the total quantity permitted by this Decision,

HAS ADOPTED THIS DECISION:


*Article 1*
