#### **Quota allocation and authorisations**

Update February 2017:

Allocation of quota: Quotas are needed for the import and production of bulk HFCs.

Quotas from the reserve are allocated annually based on a declaration of (additional) anticipated needs. The dates of the declaration period for 2018 quota have been published in the Official Journal. Companies wishing to apply for import and production of bulk HFCs from the reserve should make a declaration in the HFC Registry in the period 1 April - 31 May 2017, 13:00 CET. Preliminary quotas for 2017 have been allocated to companies that made a declaration in the period 1 April - 31 May 2016 ("New Entrants"), and to incumbent companies (see definition below) based on their reference values. Companies concerned are invited to go to HFC Registry to onsult their quotas. Some companies received penalties due to an their quotas in 2015.



#### PROTECTION OF THE OZONE LAYER AND REDUCING F-GASES

The European Union has a strong commitment to protect the ozone layer and has put in place legislation that is among the strictest and most advanced in the world. The EU has not only implemented what has been agreed under the Montreal Protocol on protecting the ozone layer but has often phased out dangerous substances faster than required. The EU is also concerned about the implications for the climate of highly warming alternatives to ozone depleting substances and has adopted stringent controls to reduce such fluorinated greenhouse gases (F-gases).

#### OZONE-DEPLETING SUBSTANCES

### LICENSING OF OZONE-DEPLETING SUBSTANCES (ODS)

Regulation (EC) No 1005/2009 prohibits imports as well as exports of ODS and products & equipment containing or relying on ODS. However, there are exemptions to this prohibition. Any exempted import and export of ODS as well as the production for essential uses is are subject to licensing. Licences are issued by the European Commission with the use of the ODS Licensing System.

#### OZONE-DEPLETING SUBSTANCES

# LABORATORY AND ANALYTICAL USE OF ODS

Regulation (EC) No 1005/2009 prohibits the use of ODS in the EU. Laboratory and analytical uses are exempted from this ban under certain conditions. Only essential laboratory and analytical uses are allowed and any undertaking using ODS for laboratory or analytical uses must be registered. The European Commission operates an electronic registry for EU internal distributers of ODS for laboratory and analytical uses and end users of ODS in laboratories.

#### FLUORINATED GREENHOUSE GASES

# THE HFC REGISTRY, HFC QUOTAS AND F-GAS DATA REPORTING

Regulation (EU) No 517/2014 foresees the implementation of a phase-down of hydrofluorocarbons (HFCs) under which the placing on the market of HFCs by each undertaking is subject to quantitative limits. From 1 January 2015 a quota is required for producers and importers placing at least 100 tonnes of CO2 equivalent of HFCs on the market in a calendar year.

The European Commission allocates quotas for placing hydrofluorocarbons on the market and operates an electronic registry for these quotas. Company reporting on fluorinated greenhouse gases listed in Annex I and II is also mandated by the Regulation.

#### WELCOME TO THE HFC REGISTRY

This is the HFC Registry, as mandated by Art. 17 of Regulation (EU) No 517/2014.

Only producers and importers of HFCs, undertakings supplying or in receipt of exempted HFCs [according to Art. 15(2)] and importers of RAC equipment precharged with HFCs need to access the Registry. If any of these apply to your organisation, this must be specified in the business specifications of your profile.

#### MY QUOTAS:

This part of the HFC Registry is for importers and producers of bulk HFCs. It allows them to see their allocated reference values and quotas as well as make and receive quota transfers.

ACCESS MY QUOTAS

#### MY DECLARATIONS:

This part of the HFC Registry allows importers and producers of bulk HFCs to make their yearly declarations of quota need, thus bidding for a possible allocation of quota from the NEW ENTRANTS RESERVE.

ACCESS MY DECLARATIONS

#### MY AUTHORIZATIONS:

This part of the HFC Registry allows importers and producers of bulk HFCs to authorise the use of quota allocated to them to importers of precharged refrigeration, air conditioning and heatpump equipment. Such an authorisation allows the importers of precharged equipment to account for gases imported inside the equipment under the quota system (Art. 14)
