instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Italy into the Community Independent Transaction Log and correcting Commission decisions C (2009) 3761 of 4 May 2009

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Italy notified by letters dated 4 March 2008 and 2 December 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 28 November 2008², as amended by Commission Decisions of 20 January 2009³ and 29 April 2009⁴ has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Italy into the Community Independent Transaction Log,
- (2) Italy notified corrections to be introduced in its national allocation plan table in order to correct typographical errors in the initial allocation plan table decision by letter dated 22 May 2009, registered on 27 May 2009 and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Italy, as revised, without objections from the Commission, on the basis of Commission Decision of 15 May 2007⁵, and respects the total quantity permitted by this Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Italy into the
