THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (1) thereof,

Whereas:

- (1) Italy notified by letter dated 4 March 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004,
- (2) The national allocation plan table corresponds to the allocation decision and is based upon the national allocation plan notified by Italy as revised, on the basis of Commission Decision C/2007/2112 of 15 May 2007. Although the information provided concerning the verification as required by Commission Decision C/2007/2112 of the data used for calculating the allocation for additional combustion installations is insufficient, the Commission is able to approve the issuance and the allocation of the annual quantity of 195 746 486 allowances that are not intended to be allocated to additional combustion installations. This quantity is within the total quantity permitted by the above mentioned Decisions.
- (3) The allowances intended to be allocated to additional combustion installations may only be approved upon the notification by Italy and evaluation by the Commission of the additional information relating to the data used for calculating their allocation.

HAS ADOPTED THIS DECISION:


Article 1
