EFTA SURVEILLANCE AUTHORITY DECISION

of 10 February 2010

instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Norway for the 2008-2012 period into the Community Independent Transaction Log

THE EFTA SURVEILLANCE AUTHORITY

Having regard to the Agreement on the European Economic Area,

Having regard to the Act referred to at point 21an of Annex XX to the EEA Agreement,

Commission Regulation (EC) No 2216/2004 of 21 December 2004 for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council,

as adapted to the Agreement by Protocol 1 thereto (hereinafter “Commission Regulation (EC) No 2216/2004”), and in particular Article 44(2), second sentence, and Article 44(4) thereof,

Whereas:

Norway notified to the EFTA Surveillance Authority (hereinafter “the Authority”) by letter dated 25 March 2009 its allocation decision for the 2008-2012 period taken under Article 11 of the Act referred to at point 21al of Annex XX to the EEA Agreement, *Directive 2003/87/EC of the European Parliament and of the Council of 13 October 2003 establishing a scheme for greenhouse gas emission allowance trading within the Community and amending Council Directive 96/61/EC*, and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44(1) of Commission Regulation (EC) No 2216/2004. The Authority, by its Decision No. 169/09/COL of 27 March 2009, has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Norway for the 2008-2012 period into the Community Independent Transaction Log.

Norway notified to the Authority corrections to be introduced in its national allocation plan table by letter dated 1 February 2010. The Authority finds that the corrections notified are in accordance with the methodologies set out in the National Allocation

Plan of Norway, as revised, without objections from the Authority, on the basis of its Decision No. 504/08/COL of 16 July 2008 and Decision No. 100/09/COL of 27 February 2009, and respect the total quantity permitted by these Decisions,

HAS ADOPTED THIS DECISION:


