COMMISSION DECISION

of 08 March 2006

on instructing the Central Administrator of the Community Independent Transaction Log to enter Latvia's National Allocation Plan table into the Community Independent Transaction Log

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 38 (1) thereof,

Whereas Latvia notified its national allocation plan table to the Commission by e-mail dated 12 December 2005, registered 25 January 2006, the Commission finds that the notified national allocation plan table corresponds to Latvia's decision on the total quantity of allowances to be distributed and on the allocation of those allowances to the operator of each installation, taken under Article 11 of Directive 2003/87/EC and is based upon the national allocation plan notified by Latvia, to which the Commission did not raise any objections in its decision of 7 July 2004 under Article 9(3) of Directive 2003/87/EC,

HAS DECIDED AS FOLLOWS:


Article 1
