COMMISSION DECISION

of 15.10.2015

amending Annex I of the Joint Procurement Agreement to procure Common Auction Platforms

THE EUROPEAN COMMISSION,

Having regard to the Joint Procurement Agreement to procure Common Auction Platforms (hereafter 'JPA-CAPs'), and in particular to Article 32(5) thereof,

Having regard to the approval of this amendment by the Joint Procurement Steering Committee on 10 August 2015,

Whereas:

- (1) At the date of the entry into force of the Auctioning Regulation¹ and the JPA-CAPs, Council Regulation No 1605/2002² (hereafter: "the former Financial Regulation") and Commission Regulation (EC, Euratom) No 2342/2002³ (hereafter: "Implementing Rules") were applicable.
- (2) Meanwhile, these legal acts have been repealed and replaced by Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council⁴ (hereafter: "the current Financial Regulation") and by Commission Delegated Regulation (EU) No 1268/2012⁵ (hereafter: "Rules of Application"), respectively.
- (3) Whereas Annex I of the JPA-CAPs needs to be amended to refer to the relevant provisions of the current Financial Regulation and its Rules of Application in place of the corresponding provisions of the former Financial Regulation and its Implementing Rules.
- (4) In accordance with Article 32(5) of the JPA-CAPs, this amendment should apply as of the date of its approval by the Joint Procurement Steering Committee.
