THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) thereof,

Whereas:

- (1) Germany notified by letter dated 4 March 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 4 November 2008², as amended by Commission Decisions of 27 February 2009³, 17 April 2009⁴, 13 August 2009⁵, 7 March 2011⁶ and 5 May 2011⁷ has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Germany into the Community Independent Transaction Log,
- (2) By letter dated 27 October 2011 Germany notified to the Commission corrections to its National Allocation Plan table for the period 2008-2012 in line with Article 44 (2) of Commission Regulation (EC) No 2216/2004,
