The path towards restarting the TF CCS

- The TF CCS had been active for several years, but was made dormant due to a lack of CCS project activities and limited topics for discussion
- This situation changed increasing number of projects in preparation or planned and proposals for new/updated regulation
- A short inventory showed high interest among experts to revive the Task Force
- The Dutch Emissions Authority (NEA) volunteered to lead the Task Force
- The Steering Committee approved the restart of the Task Force
- 19 countries joined to date; several members submitted suggested topics for discussion
- A draft workplan was formulated and shared.
- This workplan will be discussed in the meeting scheduled for this afternoon



Planned Task Force activities

- Legal and MRV implementation issues in existing M&R rules on Carbon Capture, transport by pipelines and Carbon Geological Storage
- Implementation issues that concern the relation between CCS in EU ETS and other relevant areas,
 e.g. free allocation and issues pertaining the CCS Directive
- Monitoring methodology for CO₂ transfer via ship or truck (domestic or cross-border)
- Information exchange between CAs in the case of (mobile) transport of CO2 cross-border
- Exchange of experiences on current and planned CCS projects
- Fit-for-55 package proposals and implications
- Information exchange and coordination with ICAP or other fora/countries to obtain information from worldwide CCS projects and to identify joint challenges
