THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>1</sup>, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Greece notified by letters dated 30 April 2008 and 7 May 2008, its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004 and the Commission, by its Decision of 5 September 2008<sup>2</sup> which was later amended by Commission Decision of 21 January 2009<sup>3</sup>, has instructed the Central Administrator of the Community Independent Transaction Log to enter Greece's National Allocation Plan table into the Community Independent Transaction Log,
- (2) Greece notified correction to its national allocation plan table by letter dated 27 March 2009, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Greece, as revised, without objections from the Commission, on the basis of Commission Decision of 29 November 2006<sup>4</sup>, and respects the total quantity permitted by this Decision,

HAS ADOPTED THIS DECISION:

### *Article 1*

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to Greece's National Allocation Plan table into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.

### *Article 2*

The corrections to Greece's National Allocation Plan table are represented in the Annex.
