Before the new AVR

- Licensing not accreditation
- > Verifiers: individual and organisation
- > Verification activity: ministerial decree implementing 2003/87/EC
- > Requirements for verifiers: government decree for personnel and technical conditions (ISO 14065 was not applied)
- > Licensing authority: competent environmental authority
- > Licensing process: desk top exercise based on submitted application documentation (no assessment)
- > Application: general data for identification, list of verification personnel and documents justifying their education, statement on having necessary number of personnel including one lead verifier, warranty/insurance, payment of licensing fee
- Administration time for licensing: 30-60 days
- **Licensing fee: ministerial decree** 100 000 HUF (app. 360€)
- > 12 organisations and 69 individuals licensed





Preparation for the new AVR

- > Feb 2012 NAT TFG established
- > March-Sept 2012 cooperation with ministry (legislation); appointment of NAT Accreditation officer, Accreditation Committee and external assessors; 2nd ETS Forum, preparation of training course materials, translation of ISO 14065 into Hungarian
- > Oct-Dec 2012 Amendment of Accreditation Act to authorise NAT to accredit ETS verifiers effective of 18 Oct 2012; ministerial decree on accreditation and recognition of verifiers accredited in other EU Member States effective of 19 Oct 2012; amendment of NAT procedures with ETS and publication on website; first training of NAT personnel involved
- > Jan-March 2013 regular meetings with ministry; translation of EU Guidance document into Hungarian and publication on NAT website; questionnaires/templates used in accreditation process prepared; training of NAT assessors/experts; NAT documentation submitted for EA Expert group training; ministry and NAT visit DG CLIMA
- > April-June 2013 ministerial decree on NAT fees amended with ETS verifiers published and effective of 7 April 2013; NAT Information Day for verifiers on 9 May 2013; regular information exchange with ministry
- > July-Sept 2013 NAT application for EA peer evaluation; based on preliminary document review EA MAC decision, on 2 Oct 2013, that conditions for exemption, as referred to in Article 64 (4) of the EU Regulation 600/2012, have been met second step of the peer evaluation including witness is scheduled for Feb 2014; 4 more trainings for assessors/experts; 3 applications received





Actions to ensure timely accreditation

Difficulties - legislation

legislations published late (Oct 2012-April 2013);MSZ EN ISO 14065:2012 only in English; accreditation is a public administrative process

Difficulties – Verifiers

preparation for accreditation started late; ISO 14065 (and related standards) and EA-6/03 brand new for them; new scopes; new requirements on number and experience of personnel; much more comprehensive application documentation; accreditation process is not only a desk top exercise (not used to assessment and witness); accreditation process is more lengthy and expensive than licensing was; not used to strict deadlines for submitting documents/information

NAT actions

all procedures and templates available far in advance for applicant on NAT website, for assessment teams on NAT intranet; using the EU templates for communications; timely appointment of assessment teams; regular harmonisation meeting of assessor/experts; reduction of NAT administrative time when possible; flexible but tight process management; more contact with clients than in all other areas of accreditation

Verifiers: information; preparation; transition

Accreditation Body: extension of accreditation activities; cooperation with regulator

and competent authority; communication; timely accreditation; EA peer evaluation

Competent Authority: cooperation

Supports these NABs need

EU: guidance documents; consultation forums; FAQ and case studies to publish

EA: harmonisation of accreditation practices; exchange of experience between NABs;

specific peer evaluation (process and timing) – ETS Network Group, TFGs; Expert

Group for peer evaluation; EA-6/03

MS: full support of the NAB; close cooperation between parties; regular exchange of

information

Verifiers: competence and preparedness; cooperation to ensure timely accreditation
