THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the periods ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 37 (2) second sentence thereof,

Whereas:

- (1) Hungary notified by letter dated 24 November 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004²,
- (2) In its decision of 27 April 2009³, the Commission approved the allocation of the total 2008-2012 quantity of 97 292 337 allowances for the 2008-2012 period, which is equal to the total quantity reduced by the allocation to the installations in the large power plant group for the years 2010-12. The allocation to this latter group was made conditional on notifying a revised allocation calculation for these installations that is done in accordance with the provisions of the national allocation plan notified by Hungary as revised, on the basis of Commission Decision C/2007/1689 of 16 April 2007,
- (3) Hungary notified by letter dated 6 January 2010 a revised allocation calculation for the installations in the large power plant group, and Hungary also notified allocations to be made to new entrants,
- (4) The Commission found that the notified revised allocation calculation and the allocations to new entrants were calculated in accordance with the provisions of the national allocation plan on the basis of Commission Decision C/2007/1689 of 16 April 2007,
- (5) The Commission adopted its Decision C(2010) 2214 of 24 February 2010 instructing the Central Administrator of the Community Independent Transaction Log to enter

corrections to the National Allocation Plan table of Hungary into the Community Independent Transaction Log,

- (6) By letter dated 3 April 2013, Hungary notified to the Commission corrections to its national allocation plan table. The corrections arise from the non-issuance of ERUs from the set-aside established under Commission Decision 2006/780/EC⁴ on avoiding double counting as a result of non-completion of JI projects and the subsequent increase by Hungary of the number of allowances to be auctioned pursuant to the first sentence of Article 5(2) of that Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the European Union Transaction Log to enter the corrections to the National Allocation Plan table of Hungary into the European Union Transaction Log in accordance with Art. 37 (2) of the Commission Regulation No 920/2010.

Article 2

The corrections to the National Allocation Plan table of Hungary are represented in Annex I.
