**COMMISSION DECISION**

**of**

**instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to Greece' National Allocation Plan table into the Community Independent Transaction Log**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>1</sup>, and in particular Article 38 (2) second sentence thereof,

Whereas

(1) Greece notified its national allocation plan table to the Commission by e-mail dated 14 June 2006, and the Commission, by its Decision of 19 June 2006<sup>2</sup>, has instructed the Central Administrator of the Community Independent Transaction Log to enter Greece' National Allocation Plan table into the Community Independent Transaction Log.



Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>1</sup>, and in particular Article 38 (1) thereof,


