instructing the Central Administrator of the European Union Transaction Log to enter corrections to the National Allocation Plan table of Lithuania into the European Union Transaction Log

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the periods ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 37 (2) second sentence thereof,

Whereas:

- (1) Lithuania notified by letter dated 7 March its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 29 November 2008², has instructed the Central Administrator of the Community Independent Transaction Log to enter the partial National Allocation Plan table of Lithuania containing the annual quantity of 7 143 686 allowances that are not part of the new entrant reserve into the Community Independent Transaction Log,
- (2) The allocation of the outstanding quantity of allowances was made conditional upon the notification by Lithuania and evaluation by the Commission of the allocation rules concerning new entrants,
- (3) Lithuania notified by letter dated 9 December 2008 the adopted legislation on the allocation rules concerning new entrants, and also notified a change to the list of installations due to its decision that one installation is no longer deemed to fall under the scope of the EU Emissions Trading Scheme,
- (4) the Commission found that the notified allocation rules and corrections are in accordance with the methodologies set out in the national allocation plan of Lithuania, as revised, without objections from the Commission, on the basis of Commission Decisions C(2006)5613 of 29 November 2006 and 13 My 2007 C(2007)3407, and respects the total quantity permitted by these Decisions,
- (5) The Commission adopted its Decision C(2009) 1134 of 9 February 2009 instructing the Central Administrator of the Community Independent Transaction Log to enter

corrections to the National Allocation Plan table of Lithuania into the Community Independent Transaction Log,

- (6) By letter dated 27 December 2012 Lithuania notified to the Commission corrections to its national allocation plan table. The corrections arise from the non-issuance of ERUs from the set-aside established under Commission Decision 2006/780/EC³ on avoiding double counting as a result of non-completion of JI projects and the subsequent increase by Lithuania of the number of allowances to be auctioned pursuant to the first sentence of Article 5(2) of that Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the European Union Transaction Log to enter the corrections to the National Allocation Plan table of Lithuania into the European Union Transaction Log in accordance with Art. 37 (2) of the Commission Regulation No 920/2010.

Article 2

The corrections to the National Allocation Plan table of Lithuania are represented in Annex I.
