THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Belgium notified by letter dated 30 July 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 10 October 2008², as amended by Commission Decision of 27 March 2009³ has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Belgium into the Community Independent Transaction Log,
- (2) Belgium notified additional allocations to be introduced in its national allocation plan table by letter dated 8 April 2009, registered on 15 April 2009 and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Belgium, as revised, without objections from the Commission, on the basis of Commission Decision of 16 February 2007⁴, and respects the total quantity permitted by this Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Belgium into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.
