Article 21 reporting and questionnaire update

- Last reporting of phase 3 data (2020 data) took place in June 2021.
- Analysis of MS responses to Article 21 in 2021 is ongoing:
 - COM Carbon Market Report published on 27 October 2021
 - COM Article 21 Technical Report will be published Q1 2022
- Update of Article 21 questionnaire for ETS phase 4:
 - 1st MS reporting before 30 June 2022
 - Update needs to be ready well ahead (understanding of the new questionnaire, reporting tool)
 - Update of questionnaire (via implementing act) expected Q1 2022. « Have your say » publication January 2022.

Update of MRR and AVR guidance documents, templates and tools

- The ETS MRVA guidance materials are being updated for phase 4 of the EU ETS.
- The update covers all the new legal developments, in particular the 1st and 2nd update of the MRR and AVR
- The work has been staged, priority has been given to the update of the Monitoring Plan template (finished). Project should be finished by February 2022.



Analysis of the use of auction revenues

- Information on the use of auction revenues fed into the Climate action progress reports of 2020 and 2021.
- Additional analysis to be done. Analysis of the use of revenues for the period 2013 2020 and identification of best practices.

 - Verification Reports (AER) for Installations (web forms)
 - Verification Reports (AER) for Aircraft Operators (excel)

Mid-Jan 2022 v3.1.0 ACC

Mid-Dec 2021 v3.0.0 PROD End Jan 2022 v3.1.0 PROD

- Release **v4.0.0**:
 - Improvement Reports (IR) for Installations (webform) and Aircraft Operators (Excel)
 - Report Version Comparison

Mid-March 2022 v4.0.0 PROD

- Release **v4.1.0**:
 - Change requests selected during Change Advisory Board (CAB).

Q2-Q3 4.1.0 PROD
