Instructing the Central Administrator of the European Union Transaction Log¹ to enter corrections to the National Allocation Plan Table of Spain into the European union Transaction Log

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010² establishing a Union Registry for the period ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council³, and in particular Article 37(2) thereof,

Whereas:

- (1) Spain notified by letter dated 8 November 2007 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 8 April 2008⁴, as amended by Commission Decisions of 27 April 2009⁵ has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Spain into the Community Independent Transaction Log,
- (2) Spain notified to the Commission by letter dated 13 December 2011 corrections to be introduced in its National Allocation Plan table to delete the installation Delphi Automotive Systems España with identifier No 847 since its permit had been revoked on 23 November 2007 - before its operator could open its account in the Spanish Registry,
