THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Finland notified its national allocation plan table to the Commission by letter dated 19 February 2008, and the Commission, by its Decision of 28 February 2008, has instructed the Central Administrator of the Community Independent Transaction Log to enter Finland's National Allocation Plan table into the Community Independent Transaction Log,
- (2) Finland notified correction to its national allocation plan table by letter dated 11 November 2008, and the Commission finds that the correction notified is in accordance with the methodologies set out in Finland's national allocation plan,

HAS ADOPTED THIS DECISION:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to Finland's National Allocation Plan table into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.
