TF Aviation in 2022

Key focus areas for 2022:

- Fit-for-55 proposals relevant to Aviation (EU ETS Aviation; CORSIA Notification; ReFuel EU Aviation)
- Scope Matrix guidance document (ad hoc working group)
- Guidance on sustainable biofuels in aviation in EU ETS (ad hoc working group)
- Ongoing development of EUROCONTROL tools
- 2 TF meetings during 2022, plus...
- Several meetings of the ad hoc Working Groups :
 - ➤ Ad hoc Working Group Compliance Scope Matrix (lead: ES)
 - ➤ Ad hoc Working Group Alternative Energy Sources in Aviation (lead: ES)
- New ad hoc working group established to address issues related to treatment of ferry/positioning flights (lead: EUROCONTROL)



Compliance Conf 2022: Aviation Breakout - summary of presentations

- DG MOVE: key outcomes from 2022 ICAO General Assembly
 - Changes to CORSIA baseline and new rules wrt sectoral/individual growth factor application;
 - Main elements of the 'Long Term Aspirational Goal' for international aviation.
- Ad hoc WG Scope Matrix: launch of the guidance 'Threshold and Reporting Obligation Guidance'.
- Ad hoc WG AESA: launch of 'Technical Guidance on Supporting Documentation Required for Zero-Rating Claims Associated to Sustainable Biofuels for Aviation in the EU ETS'.
- DG CLIMA & Portugal: Reflections on FF55 ReFuelEU Aviation proposal, links/synergies with ETS-Aviation and first thoughts on implementation issues.



Compliance Conf 2022: Aviation Breakout - actions identified from the Breakout

- As the Matrix/Biofuels guidance documents start being used, we can learn from feedback from users, in order to update these where necessary.
- The ad hoc WGs need to continue their work to prepare additional guidance (e.g. update scope matrix for revised ETS-Avt; treatment of biofuels in ECTL Support Facility).
- Reflect on the interaction of ETS-Aviation and ReFuel EU Aviation, vis-a-vis use of biofuels in aviation.
- Need to reflect on the scope of work of TF Aviation (possibly also, of the Compliance Forum).



Moving forward: 2023

Focus of TF work for 2023:

- Exchange of experiences from EU ETS + CORSIA + CH ETS implementation;
- Fit-for-55 proposals: subject to conclusion of trilogues, to follow-up on implementation matters of amended EU ETS Directive;
- Continue the work of the ad hoc WGs;
- Continue support to EUROCONTROL in respect of tools.
