Instructing the Central Administrator of the European Union Transaction Log to enter corrections to the National Allocation Plan Table of Cyprus into the European Union Transaction Log

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010¹ establishing a Union Registry for the period ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council², and in particular Article 37(2) thereof,

Whereas:

- (1) Cyprus notified by letter dated 8 November 2007 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 11 July 2009, was later amended by Commission Decisions of 13 April 2010³, of 01 August 2011⁴ and of 23 November 2012⁵, has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Cyprus into the Community Independent Transaction Log,
- (2) By letter dated 27 December 2012 Cyprus notified to the Commission corrections to its National Allocation Plan table for the period 2008-2012. The notified change implies a transfer of all not used 2012 Set-aside allowances to the 2012 allocations of the three existing power generation installations, and an equivalent increase of the total allowances to issue,
