Work Plan of the Union for the Mediterranean Climate Change Expert Group 14th October 2014

1. Working groups and areas of focus for the work of the UfMCCEG

(1) Scenario development and knowledge base

- Improving knowledge base of the changing climate system in the Mediterranean region;
- Setting up national inventories.
- GHG emissions modeling in practice – on the example of proposed projects and initiatives;
- Prospective scenarios and relations with scientific community.

(2) Low carbon and climate resilient programmes or projects

LEDS, NAMAs, NAPs, DRR:

- Strategic and policy planning:
 - National climate change policies, intended nationally determined contributions, low emissions development strategies;
 - Nationally appropriate mitigation actions;
 - National adaptation plans, disaster risk reduction including their linkages.
- Programmes/projects in specific sectors:
 - Benefits of low-carbon and green economies;
 - Climate-smart agriculture and landscapes;
 - Sustainable consumption and production, in particular low-emissions practices in industry and businesses;
 - Climate-smart infrastructure in the context of sea level rise and flash floods; drought and very low precipitation
 - Water-energy-food nexus;
 - Sustainable urban development including integrated coastal zones management (ICZM) – adaptation and eco-cities;

(3) Mainstreaming and climate finance:

- Mainstreaming across different policy areas;
- Role of cities and communities in mainstreaming climate change policies and projects ;
- Development of innovative approaches: business model development involving private sector;
- Building awareness and capacities of local/national financial institutions in green and low carbon financing;
- Investors' conferences.
