Commission Decision instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Slovenia into the Community Independent Transaction Log and correcting Commission Decision C (2009) 3384

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Slovenia notified by letter dated 18 September 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004, and the Commission, by its Decision of 30 September 2008², later amended by its decision of 27 February 2009³, has instructed the Central Administrator of the Community Independent Transaction Log to enter the National Allocation Plan table of Slovenia into the Community Independent Transaction Log,
- (2) Slovenia notified additional corrections to be introduced in its national allocation plan table due to the application of Slovenia's new entrants' provisions by letter dated 2 March 2010, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Slovenia, as revised, without objections from the Commission, on the basis of Commission Decision of 5 February 2007⁴, and respects the total quantity permitted by this Decision,
- (3) A typographical error was found in the Commission's decision of 22 April 2009 instructing the Central Administrator of the Community Independent Transaction Log to enter corrections to the National Allocation Plan table of Sweden into the Community Independent Transaction Log⁵, whereby the correction to the allocations of one installation was omitted from the Annex, and this needs to be rectified. As the corrections to the Community Independent Transaction Log intended by the above-mentioned decision were done correctly, there is no need to enter additional correction into the Community Independent Transaction Log itself.

HAS ADOPTED THIS DECISION

Article 1
