THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) second sentence thereof,

Whereas:

- (1) Sweden notified by letter dated 18 July 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004 and the Commission, by its Decision of 8 August 2008² which was later amended by Commission Decision of 18 December 2008³, has instructed the Central Administrator of the Community Independent Transaction Log to enter Sweden's National Allocation Plan table into the Community Independent Transaction Log,
- (2) Sweden notified correction to its national allocation plan table by letter dated 9 February 2009, and the Commission finds that the correction notified is in accordance with the methodologies set out in Sweden's national allocation plan,

HAS ADOPTED THIS DECISION:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to Sweden's National Allocation Plan table into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.

Article 2

The corrections to Sweden's National Allocation Plan table are represented in the Annex.
