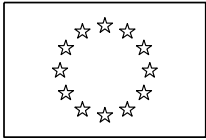

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (2) thereof,

Whereas

- (1) The Commission, by its Decision of 21 February 2008² which was later amended by Commission Decisions of 27 March 2009³ and 29 April 2009⁴, has instructed the Central Administrator of the Community Independent Transaction Log to enter Austria's National Allocation Plan table into the Community Independent Transaction Log.
- (2) On 10 December 2009, the Commission has approved the application submitted by Austria for the unilateral inclusion in the Union scheme of the emission of nitrous oxide (N₂O) associated with the production of nitric acid (HNO₃) as an additional gas and activity in its decision C(2009)9849. Austria notified by letter dated 9 November 2010 further changes to its National Allocation Plan table for the 2008-2012 in line with Article 44(2) of Commission Regulation (EC) No 2216/2004,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Austria into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.
