## COMMISSION DECISION

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Commission Regulation No 920/2010 of 7 October 2010<sup>2</sup> establishing a Union Registry for the period ending 31 December 2012 of the Union emissions trading scheme pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council<sup>3</sup>, and in particular Article 37(2) thereof,

Whereas

- (1) The Commission, by its Decision of 21 February 2008<sup>4</sup> which was later amended by Commission Decisions of 27 March 2009<sup>5</sup>, 29 April 2009<sup>6</sup> and 20 January 2011<sup>7</sup> has instructed the Central Administrator of the Community Independent Transaction Log to enter Austria's National Allocation Plan table into the Community Independent Transaction Log.
- (2) By letter dated 17 October 2011 Austria notified to the Commission corrections to its National Allocation Plan table for the period 2008-2012,

HAS DECIDED AS FOLLOWS:

### *Article 1*

The Commission instructs the Central Administrator of the European Union Transaction Log to enter the corrections to the National Allocation Plan table of Austria into the European Union Transaction Log in accordance with Art. 37(2) of Commission Regulation No 920/2010.
