THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 44 (1) thereof,

Whereas

- (1) Austria notified by letters dated 30 April 2008 and 7 May 2008 its allocation decision for the 2008-2012 period taken under Article 11 of Directive 2003/87/EC and its national allocation plan table for the 2008-2012 period drawn up on the basis of Article 44 (1) of Commission Regulation (EC) No 2216/2004.
- (2) The Commission, by its Decision of 21 February 2008² which was later amended by Commission Decision of 27 March 2009³, has instructed the Central Administrator of the Community Independent Transaction Log to enter Austria's National Allocation Plan table into the Community Independent Transaction Log.
- (3) Austria notified additional allocations to be introduced in its national allocation plan table by letter dated 31 March 2009, and the Commission finds that the corrections notified are in accordance with the methodologies set out in the national allocation plan of Austria, as revised, without objections from the Commission, on the basis of the Commission Decision of 2 April 2007⁴ and respects the total quantity permitted by this Decision,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter the corrections to the National Allocation Plan table of Austria into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.


